SWIMMING LESSON RULES

Failure to comply with the pool rules will result in a cancellation of your swim lessons.

1. No Cancellations or rescheduling (unless previously discussed with management/pool staff).
2. If you are asked by staff to get into the water with your student, please be ready to do so, staff will give you a 24 hour notice prior.
3. No cotton swimming attire is permitted in the pool (including undergarments).
4. No running or horseplay in the pool area.
5. No outside food, eating or drinking is allowed in pool area. Only bottled water is permitted.
6. Parents/ Adult must be in attendance in the pool area during each session.
7. If student has experienced any diarrhea or flu like symptoms before the class, the lesson must be rescheduled (rescheduling will be based on availability).
8. The swimming lesson block lasts for three (3) weeks. All VMRC parents must reach out to their student's Service Coordinator when report card is given, if they wish to continue attending.
9. Non VMRC students, class fee must be paid in full before attending the first session. Scheduling is to be done with office staff when report cards are given, if they wish to continue.
10. No excessive splashing (towards our other consumers).
11. No spitting or hitting is allowed.
12. If student is not potty-trained parents must provide swim diapers/or plastic liners and are to be worn during each swim lesson.
